Tiada halangan untuk pemohon mendapatkan penajaan pihak luar bagi keperluan teknikal, video dan peralatan seperti projektor, peranti digital, skrin dan lain-lain. Sebarang kos sewaan dan keperluan karya adalah di bawah tanggungan pemohon.

Balai Seni Negara menyediakan ruang pameran iaitu di lobi pintu masuk utama galeri. Tema karya adalah bebas. Karya yang dipamerkan mestilah tidak mengandungi sebarang elemen atau bentuk yang berunsur lucah, hasutan atau sensitiviti yang boleh mengganggu ketenteraman awam seperti perkauman, keagamaan, atau mengaibkan mana-mana individu, kumpulan dan negara. Kos pengangkutan dan pemasangan karya adalah di bawah seliaan dan tanggungan pemohon.

Please state the technical requirements, sketches, explanations, research ideas and work statements. The project paper must be accompanied by references (Curriculum vitae, catalogue, e-book, website, social media and others)

There is no restriction for applicants to obtain third-party sponsorship for technical, video and equipment needs such as projectors, digital devices, screens, and others. Any rental costs and work requirements are under the responsibility of the artist.

The National Art Gallery of Malaysia provides a main space at the entrance of the gallery for artists to display their works. The theme of the artwork is open. However, the exhibited artwork must not contain any element or form of obscenity, incitement, or sensitivity that may disturb public order such as racism, religion, insult or humiliation to any individual, group and country. The cost of delivery and the installation of the artwork is under the supervision and responsibility of the applicant.
